This client agreement including the following terms and conditions is a contract for services provided by TreDesMo Visions (referenced herein as 'Photographer'). It supersedes all prior and simultaneous agreements between the parties. The only way to add or change this agreement is to do so in writing, signed by all the parties. If the parties want to waive one provision of this agreement it does not mean that any other provision is also waived. The party against whom a waiver is sought to be effective must have signed a waiver in writing. The Photographer should be notified immediately of any changes in scheduling or location. It is the client's responsibility to confirm all arrangements 7-10 days prior to the date of the event/photo shoot and to notify the Photographer immediately of any change of address or contact information as listed on this contract.

PACKAGES **~ECONOMY**

- ✓ All edited photos taken will be available at a private web address for your early proofing.
- ✓ Client will be provided with a Photo CD (mainly for email and sharing via social networking sites) with the best edited proofs taken.
- ✓ We offer wholesale pricing on prints and enlargements.



- ✓ The Two (2) hour minimum required deposit (\$200.00) will be due at the time of booking. The remaining amount (if any) will be due before any proofs are shown or displayed.

~BRONZE

- ✓ Photography coverage for the ceremony and reception (up to 4 hours), including candid shots from both.
- ✓ Unlimited edited portraits with a High Resolution Copyright-Free CD.
- ✓ Your own private website photo gallery for 30 days via our website.
- ✓ Up to 100 (4x6) images included in a standard classic photo album.
- ✓ 100 Customized photo thank you cards w/envelopes for your guests with One (1) wedding picture of your choice.

~SILVER

Includes everything in the BRONZE package ***EXCEPT*** replacing the standard classic photo album with:

- ✓ A beautiful 8.5x11 black (or blue) suede hard cover photo book, customized with up to 100 of your edited images and embossed with foil stamping with your name and wedding date.
- ✓ Up to Six (6) hours of coverage for both the wedding and the reception
- ✓ 100 glossy photo bookmarks with One (1) image of your choice on the front.
- ✓ 160 - 3.5"x2" Customized "Save The Date" Photo Magnets to send before the wedding.

~GOLD

Includes everything in the SILVER package along with:

- ✓ A photo engagement shoot (up to 5 images) at a location of your choice.
- ✓ Ten (10) photos of your choice enlarged to 8x10 size (choice of engagement and/or wedding photos).

~DIAMOND

It contains everything from the GOLD package including:

- ✓ Two (2) photo enlargements 11x14 sized gallery wraps with the prints of your choice.
- ✓ A beautiful vibrant slideshow DVD of your edited prints, customized with up to three (3) of your song selections.
- ✓ One (1) 16x20 photo sign-in board for your reception using a photo from your engagement session. Perfect for a keepsake and framing!



- ✓ Your own fully customized personal "Wed Site" that will be available as soon as you book your date with us until (2) two months after your wedding has ended. Your guests can find out ceremony & reception information, get directions, view your photos & best of all, find your registry information.

DESCRIPTION OF SERVICES

TreDesMo Visions will provide high quality photographic services for the event(s) described above. Unless otherwise noted, we will provide one professional photographer to take photographs using digital camera equipment, producing "Digital Images" in .JPG format. In addition to the primary photographer assigned, TreDesMo Visions may use additional photographers and/or assistants at its discretion.

Proof photographs shall be delivered to the Client via Photographer's website with a username and password provided. The Client shall provide the Photographer with a written list of the proof images from which final photographs are to be prepared, and specify the number and format(s) of the final photograph to be delivered for each proof image.

COOPERATION

The parties agree to cheerful cooperation and communication for the best possible result within the definition of this assignment. TreDesMo Visions Photography recommends that the Client designate an "Event Guide" to point out important individuals for informal or candid photographs to the Photographer during the wedding that they wish to have photographed. The Client shall assist and cooperate with the Photographer in obtaining the desired photographs, including but not limited to specifying persons and/or scenes to be photographed; taking time to pose for photographs at the Photographer's direction; providing a person to guide the Photographer to desired persons and/or scenes; The Photographer shall not be responsible for photographs not taken as a result of the Client's failure to provide reasonable assistance or cooperation.

The Photographer is the sole professional photographer allowed to photograph the event. Amateur photographers may take photos during the event if they do not interfere with the contracted photographer and are not shooting our same posed shots. If a problem arises with any guest or attendee(s) the on-site event representative (the Client/Event Guide) will be advised to handle the situation politely for us by enforcing the conditions of this contract.

COPYRIGHT, LICENSE TO USE, AND MODEL RELEASE

It is understood that the Photographer owns the copyright to all of the Digital Images and reserves the right to use them for display, publication, advertising or other purposes. Upon receipt of final payment, the Client is granted a Non-Exclusive Unlimited License to use the Digital Images for their own non-commercial purposes, such as printing, electronic messaging, exchange with friends and relatives, or display on the Internet. **No Digital Images will be provided to the Client until full payment has been made.**

DEPOSIT, RESERVATION AND SCHEDULING (FOR PERSONAL EVENTS)

The balance is due no later than two (2) weeks before **the day of** the wedding. Any overtime fees approved verbally by the Client during the event are due upon completion of the event. Upon signature and receipt of the deposit, the Photographer will reserve the specified date and time for the event.

If the Client wishes to cancel this Agreement 30 or more calendar days before the event date, any deposit paid to the Photographer will be refunded to the Client in full. If the Client cancels the event within two weeks of the



event date and if the Photographer cannot obtain another assignment for that date, 50% of the deposit will be refunded.

ARCHIVAL STORAGE OF FILES

TreDesMo Visions stores electronic files of your images for many years. This does not include those images that are not among those presented to clients as proofs. If a client wants a digital copy of those ‘rejected’ files they will be available separately for purchase at a nominal fee. In addition, although extensive efforts are made to store all ‘non-rejected’ images for several years, there is no guarantee that a catastrophic event such as a fire, theft or other disaster will not destroy all files that we are archiving. In the event that archived files are destroyed or lost, the Photographer cannot be held liable and will not pay reparations for anything beyond products which have been paid for but not yet received.

OTHER SERVICES

This contract is for the photography services and electronic delivery of the Licensed Digital Proofs only. With this contract, you will be provided with a **Low-Resolution CD** (for social sharing such as Facebook, email, etc.). Additional services, such as providing **High-Resolution** Digital Images on physical media (CDs, prints, etc.) are available as a separate order depending on which package is chosen.

PHOTOGRAPHER’S STANDARD PRICE LIST

The charges related to this Agreement are based on the Photographer's written price list. Deposits paid for event packages will secure the prices in effect at the time the deposit is paid. The price of prints and other additional listed items is valid for one month after the initial viewing of images. However, this price list is adjusted periodically and future orders will be charged at the prices in effect at the time when the order is placed. The following price list is as follows:

We also offer additional items for purchase. Please inquire about any other specific needs you may require.

MILEAGE

Photographer charges .55 cents a mile for any location outside of the Houston County area we have to travel to.

LIMITATION OF LIABILITY

In the unlikely event that all of some of the photographs fail to materialize or there is total photographic failure due to reasons beyond TreDesMo Visions’ control, the liability of TreDesMo Visions will be limited to the refund of all money paid. Neither party shall be liable for indirect or consequential losses. In any event, the limit of TreDesMo Visions liability shall not exceed the Package Price.



FAILURE TO PERFORM

If the Photographer cannot perform this Agreement due to an injury, illness or other cause beyond the control of TreDesMo Visions, then the Photographer will return all payments made by the Client but will have no further liability with respect to the Agreement. In such events the Photographer will make a good faith effort to secure a substitute photographer who will work under the previously made arrangements. This limitation on liability will also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, or otherwise lost or damaged without fault on the part of the Photographer. In the event the Photographer fails to perform for said reasons and is unable to secure an alternative photographer, TreDesMo Visions will not be liable for any amount in excess of the amount paid by the Client.

APPLICABLE LAW

This contract shall be governed by the laws of the County of Houston in the State of Georgia and any applicable Federal law.
